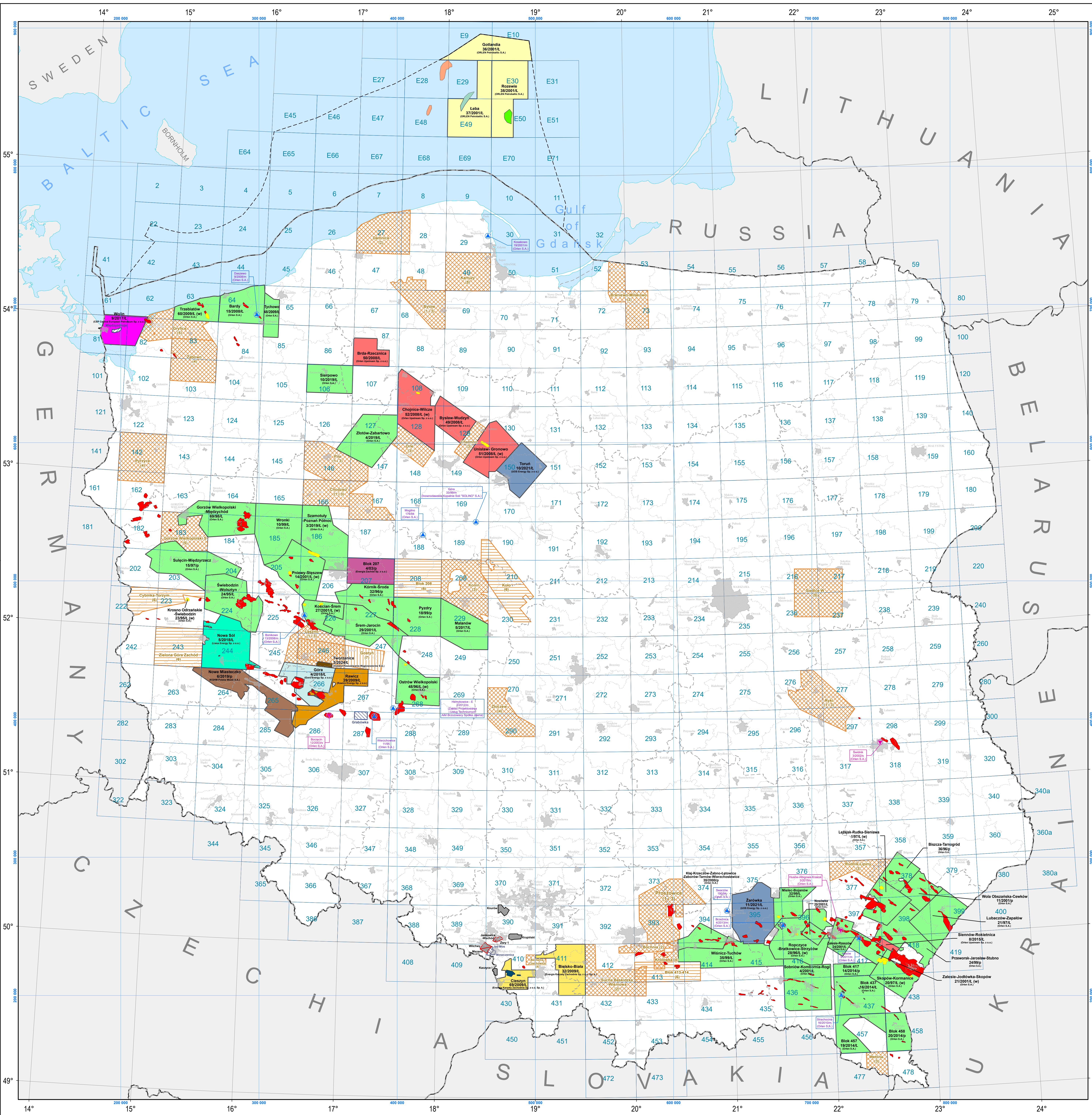


MAP OF CONCESSIONS FOR HYDROCARBON PROSPECTING, EXPLORATION AND PRODUCTION,
